How will the funds be used?

The funds contributed by VMC will be used to complete the fundraising goals in the budget. SPACE is a non-profit performing arts school serving youth and young adults in the Ukiah Valley. Each year revenue from fundraisers, grants, individual and business donations make up 50-75% of the program budget. Serving over 1,000 youth per year, the entirety of the proceeds for SPACE will further its mission:

To empower our youth to discover and trust in their innate ability to be creative, responsible, and compassionate individuals through effective training in dance, theater, music and cultural education.

In addition, this year, 10% of the ticket sales will be contributed to the Community Foundation of Mendocino County's fund to aid the recent fire victims.

How do you feel the out-of-town visitor will benefit from your event or program?

Visitors will benefit from attending this event by being exposed to a diverse group of artists (most of whom were raised in Mendocino County) in a single performance. Exposing visitors to Mendocino talent helps establish the region as a destination and reinforces the "Ukiah Grows the Arts" theme promoted by many local agencies.

Performers include:

Holly Near was raised in Potter Valley and has toured the world as a singer/song writer, performed on Broadway and survived Breast Cancer- returning to her hometown stage with new life and energy.

Quinn VanAntwerp grew up in Ukiah, earned a degree from University of California, Irvine, and starred in Jersey Boys, both on Broadway and on tour. He can be seen in The Affair, The Good Wife, Blue Bloods and many other TV series.

Lucas Near-Verbrugghe also grew up in Ukiah, earned a Masters in Fine Art from NYU and has been on Broadway in Bloody Blood Andrew and The Ritz. Lucas has numerous TV credits including Grimm, Law and Order, Law and Order SVU and Ten Days in the Valley.



Rocio Mendoza was born in Colima, Mexico and grew up in Mendocino County where she learned Mexican folk melodies from her parents. She has appeared in numerous music videos and as a dancer and has performed with Black Eyed Peas, Carlos Santa and N'Sync.

How do you feel the lodging community (hotels, motels, inns, vacation rentals, RV parks & campgrounds) will benefit from your event program?

The local lodging community will gain business from our event, both in lodging for the performers, performers' families and out-of-town visitors coming to Ukiah to attend the event. In addition, the Hampton Inn and Campovida have donated rooms for select performers and will gain advertising for the support through event advertising materials.

How do you feel the sales tax business community (retail, restaurants, etc.) will benefit from your event/program?

The local business community benefits from the Holly Near & Friends event both directly and indirectly. Many attendees will eat and shop in the downtown area prior or after attending the shows. In addition, guests to our area will be exposed to local wines and food as part of our hors d'oeuvres and wines served during intermission of the show.

Indirectly, the local business community benefits from the investment in local youth the event will provide. Investment in SPACE is investing in the future of Ukiah youth-reducing crime and producing more successful young adults in our community.

How do you feel the municipalities (county & city governments) will benefit from your event/program?

SPACE feels the local municipalities benefit from the positive notoriety that the performers bring back to Mendocino County. The artists in the show call Ukiah and Mendocino County "home" and return regularly to help SPACE with summer programs, and other performing arts training for local youth. This dedication to the region helps continue the traditions within our community and helps to spread the word about Mendocino County as an arts community worth visiting.

The local law enforcement, including the Mendocino Sheriff and District Attorney and Ukiah Police Chief have historically provided a combined \$10-20,000 in scholarship funds annually. Each agency has expressed its understanding and support for SPACE's program, specifically as a way to positively influence local youth- particularly impoverished, and/or high-risk youth.

Hi Luz.

Thanks for asking for clarification. Because so many of our tickets are sold anonymously, specifically at the Mendocino Book Company, we don't have a way to track this information. It's an estimate from what we know about who generally attends.

In making our estimates we know a few things about our audience that would impact these numbers.

- attendees will travel with a spouse or family members, needing only one room- though buying multiple
 tickets for the show.
- some attendees that will come from Sonoma and Lake counties and will not stay overnight.
- there are also a few people who buy tickets to both shows (on the same day) and will only stay one night.

I hope this helps. In the future we will consider tracking this data more carefully, but since this is our first time applying for this funding, it's never been something we documented. Please let us know if you have additional questions.
